- Economic Justice- Tuition Equity laws for undocumented students

Knowledge of these topics is beneficial, but not required.

## 1. Policy Education, Advocacy, and Training:

- o Stay informed on the latest policy trends, legislative processes, and best practices for effective advocacy.
- o Participate in training or workshops related to public policy, advocacy, and committee responsibilities.

# 2. Advocacy and Community Engagement:

o Represent the committee at public hearings, community meetings, and other advocacy events.

- o Build and maintain relationships with key stakeholders, including local government officials, community organizations, advocacy groups, and the public.
- o Advocate for policies that address the priorities and concerns of Duval County residents.
- o Seek out organic opportunities to engage the community.

### **Committee Requirements**

- 1. Required in-person attendance at monthly committee meetings.
- 2. Host monthly gatherings within the respective community focused on advocacy topics or related material.
- 3. Data tracking and engagement via monthly reporting form.
- 4. Attempts to broaden reach and influence larger audience over time.
- 5. Photos of gatherings and continued learning opportunities.
- 6. Attendance at at least two 904WARD Wine Down Wednesday events.
- 7. Attendance at relevant public meetings (City Council + School Board) and willingness to make public comments when requested.
